## Instructions (PLEASE PRINT)

- 1. Complete this form and mail, email, fax or deliver to Kelly Kenney, Chief Election Officer, Langley City Hall, 20399 Douglas Crescent, Langley, BC V3A 4B3, Fax: 604.514.2838 / Email: <a href="kkenney@langleycity.ca">kkenney@langleycity.ca</a>
- If your application is complete and you qualify to vote either as a resident elector or non-resident property elector, a mail ballot package will, per your request, be mailed to you or made available for pick-up commencing on or about September 26.
- 3. You are responsible for ensuring that your completed ballot package is received by **8:00 pm on Saturday**, **October 15, 2022**. You can mail the completed ballot package to *Chief Election Officer*, *c/o Langley City Hall*, 20399 Douglas Crescent, Langley, BC V3A 4B3, or deliver the ballot package in person as noted below.

Your completed ballot package may be delivered in person to the Administration Department (second floor) of Langley City Hall at the above address during regular business hours, Monday – Friday, 8:30 am to 4:30 pm, OR at the following locations and times:

- Tuesday, October 4 (1:00 pm to 8:00 pm);
- Wednesday, October 5 (8:00 am to 8:00 pm)

At Advance Voting Opportunity at the Langley Senior Resources Society Recreation and Resource Centre, 20605 – 51 B Avenue on:

• Thursday, October 6 (8:30 am to 4:30 pm)

On General Voting Day at Timms Community Centre, 20399 Douglas Crescent on:

• Saturday, October 15 (8:00 am to 8:00 pm)

Mail Ballot Packages received after 8:00 pm on October 15th cannot be accepted.

Important: Once you request a mail ballot you may not, at a later date, choose to vote in person instead.

And I request that I receive a ballot to vote by mail, under the provisions of Section 110 of the *Local Government Act*, for the 2022 City of Langley and School District No. 35 Election to be held on Saturday, October 15, 2022.

## To be eligible to vote in the election you must be:

- 18 years of age or older on general voting day; and
- a Canadian citizen; and
- a resident of BC for at least six months immediately before the day of registration; and
- a resident of Langley City; OR
- a registered owner of real property in Langley City for at least 30 days immediately before the day of registration; and
- if a non-resident property elector, not holding the property in trust for a corporation or any other trust; and
- not otherwise disqualified by law from voting.

## Important: Collection, Use, and Disclosure of Personal Information on this Form

Personal information requested on this form is collected under the authority of Section 26 of the *Freedom of Information and Privacy Act, R.S.B.C.* 1996, c. 165.

Unless otherwise specified, the information gathered will be used by the chief election officer to comply with Section 110 (6) of the *Local Government Act, R.S.B.C 2015 c. 1* which requires that the chief election officer keep sufficient records so that challenges of an elector's right to vote may be made in accordance with the intent of section 126 [challenge of elector].

Accordingly, the elector's name and residential address (if non-resident property elector, both residential address and address of real property in relation to which elector is voting) will be made available, upon request, for public inspection until the deadline of 3:00 p.m. October 13, 2022, at Langley City Hall, 20399 Douglas Crescent during regular business hours which are 8:30 am to 4:30 pm, Monday to Friday, excluding statutory holidays.

In accordance with Section 78 of the *Local Government Act*, an elector who has applied to receive a mail ballot may request that their address or other information about them be omitted from or obscured from the list of mail ballot applicants that will be made available for public inspection.
