WHEREAS the Council of the City of Langley deems it expedient to provide for a bylaw for the purpose of enforcing the bylaws of the City;

NOW THEREFORE the Council of the City of Langley in an open meeting assembled enacts as follows:

1. Title

This bylaw shall be cited as the "Municipal Ticket Information System Bylaw, 2011, No. 2846".

2. **Definitions**

(1) "City" means the City of Langley.

3. General Provisions

- (1) The bylaws listed in Column 1 of Schedule "A" of this bylaw may be enforced by means of a ticket in the form prescribed for the purpose of section 264 of the *Community Charter*.
- (2) The persons who act in the job positions or titles listed in Column 2 of Schedule "A" to this bylaw are designated bylaw enforcement officers for the purpose of enforcing the bylaws listed in Column 1 of Schedule "A" opposite the respective job position.
- (3) The words or expressions set forth in Column 1 of Schedule "B1" through "B25" of this bylaw designate the offence committed under the bylaw section number appearing in Column 2 of Schedule "B1" through "B25" opposite the respective words of expression.
- (4) The amounts in Column 3 of Schedule "B1" through "B25" of this bylaw designate the fines for contraventions of the bylaw offences set out in Column 1 of Schedule "B1" through "B25" opposite the respective amounts.
