3. DISCUSSION

1. Urban Forestry Management Strategy (UFMS)
 - 1.1. Diamond Head Consulting presented the UFMS draft strategy outlining four Goals each with specific Strategies and Actions. The Committee discussed the various initiatives, such as a tree protection bylaw, and education.
 - 1.2. The Committee discussed the next steps of the second round of public engagement that will take place over the next three months including a survey (both online and hard copy), an Open House and possibly pop-up engagement at events such as Community Day.
 - 1.3. Having compiled the data from the second round of public engagement, Diamond Head Consulting will craft a Draft UFMS for review and ultimate endorsement by Council.
 - 1.4. The Committee discussed the need for any trees to be planted in the future to be climate resilient. Staff noted that the City has an extensive catalogue of trees for consideration along with the appropriate soil growing medium. Diamond Head Consulting noted that they have previously prepared a document for Metro Vancouver titled "Urban Forest Climate Adaptation Framework for Metro Vancouver" and agreed to forward the link to the report, along with a database of suitable trees for the Committee's perusal.

2. Earth Day 2024
 - 2.1. Committee members discussed the components of the program for Earth Day 2024, including:
 - 2.1.1. Committee Member confirmed that the Douglas Park Rec Centre will be open for the event, and tables, chairs, etc. will be on site. The bike valet will be in the Rec Centre.
 - 2.1.2. There was discussion around prizes, and ballots.
 - 2.1.3. The Committee discussed various trees and agreed that an Asian pear tree will be planted on Earth Day.
