VOTING DATES AND LOCATIONS

GENERAL VOTING will be open to qualified electors of the City of Langley on:

Saturday, October 15, 2022 between the hours of 8:00 am and 8:00 pm at Timms Community Centre 20399 Douglas Crescent, Langley, B.C.

ADVANCE VOTING will be available to qualified electors at the locations and times as follows:

Timms Community Centre, 20399 Douglas Crescent, Langley:

- Tuesday, October 4, 2022, from 1:00 p.m. to 8:00 p.m.
- Wednesday, October 5, 2022, from 8:00 a.m. to 8:00 p.m.
- Wednesday, October 12, 2022, from 8:00 a.m. to 8:00 p.m.

Langley Senior Resources Society Recreation and Resource Centre, 20605 51B Ave., Langley:

Thursday, October 6, 2022, from 8:30 a.m. to 4:30 p.m.

Curbside voting will be available outside the voting locations referenced above for anyone who cannot enter the voting location and wishes to vote from their vehicle

VOTING BY MAIL BALLOT

The option to vote by mail ballot is available to all qualified electors.

To obtain a mail ballot, qualified electors must submit an application to the Chief Election Officer. The Application to Vote by Mail is available on the City's website or can be requested from the Administration Department at Langley City Hall by emailing paulakusack@langleycity.ca or by calling 604-514-4585.

Please note that once a request is made to vote by mail, an elector cannot instead choose to vote in person at a later date Mail ballot packages may be provided to electors in one of three ways:

- Sent by regular mail to elector's residential address;
- Sent by regular mail to an alternate address as requested by elector;
 Picked up at the Administration Counter at City Hall during regular business hours;

The City of Langley will make available/send out mail ballot packages commencing on or about September 26, 2022.

If an elector's application to vote by mail is received after September 29, they will only be able to receive their mail ballot package by pick-up at City Hall.

If an elector wishes to have someone pick up their mail ballot package on their behalf, that individual will be required to fill out a Declaration of Person Obtaining a Mail Ballot Package on Behalf of an Elector form and show two pieces of ID to the Election Official before the mail ballot package will be provided. Completed mail ballots may be submitted to the Chief Election Officer in one of three ways:

- Mailed to the attention of the Chief Election Officer, Administration Office, second floor, Langley City Hall, 20399 Douglas Crescent, Langley, BC V3A 4B3;
- Submitted in person to the Chief Election Officer or their designate at the Administration Counter at City Hall during regular business hours:
- Submitted in person to the Chief Election Officer or their designate at the voting location on Advance Voting Days and/ or General Voting Day during voting hours.

To be counted for the election, completed mail ballots must be received by the Chief Election Officer no later than 8:00 p.m. on general voting day October 15, 2022.

AVAILABILITY OF LIST OF ELECTORS APPLYING TO VOTE BY MAIL

A list of the electors who apply to vote by mail will be maintained by the Chief Election Officer. Beginning August 30, 2022, through 3:00 p.m. on October 13, 2022, the list will be available for public inspection at the Administration Department, second floor, Langley City Hall, 20399 Douglas Crescent, Langley, B.C., during regular office hours, Monday to Friday, excluding statutory holidays. Before inspecting the list, a person must sign a statement that they will not inspect the list or use the information included in the list except for the purposes of Part 3 – Electors and Elections of the *Local Government Act*. An elector who has applied to receive a mail ballot may request that their address or other personal information about them be omitted from or obscured on this list by contacting the Administration Department at 604-514-4585.

CHALLENGE OF AN ELECTOR VOTING BY MAIL

A challenge of a person's right to vote by mail ballot may be made in accordance with Section 126 of the Local Government Act until 3:00 pm on October 13, 2022. A challenge may only be made by a person entitled to be registered as an elector of the City of Langley, or a candidate representative, or an election official, and can only be made on the basis that a person whose name appears on the list of electors who have applied to vote by mail is not entitled to vote or has contravened section 161(3) of the Local Government Act (accepting inducements).

ELECTOR REGISTRATION

To vote, you must be registered either as a resident elector or a non-resident property elector of the City of Langley.

The City of Langley uses the provincial voters list as its list of electors. If you are on the list of electors, you are automatically registered to vote.

If you are not on the list of electors, you may register at the time of voting by completing the required application form available at the voting location. To register you must meet ALL the following qualifications:

- 18 years of age or older on general voting day (October 15, 2022);
- Canadian citizen:
- resident of B.C. for at least 6 months immediately preceding the day of registration;
- · resident of the City of Langley; OR
- registered owner of real property in the City of Langley for at least 30 days immediately preceding the day of registration, and
- · not disqualified by the Local Government Act or any other enactment from voting in an election, or otherwise

I To register, resident electors must produce two pieces of identification (at least one with a signature). Picture identification is not necessary. The identification must prove both residency and identity.

To register, non-resident property electors must produce two pieces of identification (at least one with a signature) to prove identity, proof that they are entitled to register in relation to the property, and, if there is more than one property owner of the property, written consent from a majority of the other property owners.

If you apply to vote by mail and are not on the list of electors, the required elector registration form(s) will be included in your mail ballot package to be completed and returned with your mail ballot.

TYPES OF DOCUMENTS THAT WILL BE ACCEPTED AS IDENTIFICATION

The following documents will be accepted as evidence of identity and residency:

- a) a Driver's Licence (Note: the dual BC Driver's Licence and Care Card are considered one (1) piece of ID);
- b) an Identification Card such as
 - i. a photo BC Services Card;
 - ii. a non-photo BC Services Card;
- c) an Owner's Certificate of Insurance and Vehicle Licence issued by ICBC
- d) a BC CareCard or BC Gold CareCard;
- e) a Ministry of Social Development and Economic Security Request for Continued Assistance Form SDES8, (now "Monthly Form EA181");
- f) a Social Insurance Number card:
- g) a Citizenship Card;
- h) a real property tax notice;
- i) a credit card or debit card; or
- j) a utility bill (such as electricity, natural gas, water, telephone, or cable services).

The above listed identification documents MUST be accepted by election officials. An election official may also accept other forms of documents that provide evidence satisfactory to the election official (e.g., a valid, current passport).
