QUALIFICATIONS FOR OFFICE

- · Canadian citizen;
- 18 years of age or older on general voting day (October 15, 2022);
- nomination papers are filed; and
- be otherwise disqualified by law.

CAMPAIGN PERIOD EXPENSE LIMITS

In accordance with the Local Elections Campaign Financing Act, for the 2022 general local elections, the following expense limits for candidates during the applied to receive a mail ballot may request that their address or other information campaign period (September 17, 2022 to October 15, 2022) apply:

Mayor - \$24,434.63

Councillor - \$12,287.10

Board of Education Trustee (Trustee Electoral Area 2) - \$11,930.40

THIRD PARTY ADVERTISING LIMITS

Directed Advertising Expense limits are specific to an election area and apply to advertising about a candidate or elector organization.

In accordance with the Local Elections Campaign Financing Act, for the 2022 general local elections, the following Directed Advertising Expense limits apply:

Mayor or Councillor - \$1,221.73

Board of Education Trustee (Trustee Electoral Area 2) - \$809.84

AVAILABILITY OF LIST OF REGISTERED ELECTORS

Beginning August 30, 2022 until the close of general voting for the election on October 15, 2022, a copy of the list of registered electors will be available for public inspection, at the Administration Department, second floor, Langley City Hall, 20399 Douglas Crescent, Langley, B.C., during regular office hours, Monday to Friday, excluding statutory holidays. Before inspecting the list, a person must sign a statement that they will not inspect the list or use the information included in the list except for the purposes of Part 3 – Electors and Elections of the Local Government Act. An elector may request that their address or other information about them be omitted from or obscured on the list of electors.

OBJECTION TO REGISTRATION OF AN ELECTOR

An objection to the registration of a person whose name appears on the list of registered electors may be made in accordance with the Local Government Act until 4:00 pm on September 14, 2022. An objection must be in writing and may only be made by a person entitled to be registered as an elector of the City of A person is qualified to be nominated, elected, and to hold office as a member of Langley and can only be made on the basis that a person whose name appears on the list of electors has died or that a person whose name appears on the list of electors is not qualified to be registered as an elector of the City of Langley.

AVAILABILITY OF LIST OF ELECTORS APPLYING TO VOTE BY MAIL

Beginning August 30, 2022 until 3:00 p.m. on October 13, 2022, • not disqualified under the Local Government Act or School Act or any other ! the list will be available for public inspection, at the Administration Department, enactment from being nominated for, being elected to or holding the office, or second floor, Langley City Hall, 20399 Douglas Crescent, Langley, B.C., during regular office ho urs, Mo nday to Fr iday, ex cluding st atutory ho lidays. Before inspecting the list, a person must sign a statement that they will not inspect the list or use the information included in the list except for the purposes of Part 3 – Electors and Elections of the Local Government Act. An elector who has about them be omitted from or obscured on this list.

OBJECTION TO REGISTRATION OF AN ELECTOR APPLYING TO VOTE BY MAIL

An objection to the registration of a person whose name appears on the list of electors who have applied to vote by mail may be made in accordance with the Local Government Act until 3:00 pm on October 13, 2022. An objection may only be made by a person entitled to be registered as an elector of the City of Langley, or a candidate representative, or an election official and can only be made on the basis that a person whose name appears is not entitled to vote or has contravened section 161(3) of the Local Government Act (accepting inducements).
